Amedisys' Chief Medical Officer Calls for All Health Care Providers to Support the National Priorities Partnership Action Briefs for Increasing Value in Health Care

BATON ROUGE, La.--(BUSINESS WIRE)--Michael Fleming, MD, Fellow, American Academy of Family Physicians, and Chief Medical Officer of Amedisys Inc., a leading home care and hospice company, called for all health care providers to support the action briefs released by the National Priorities Partnership (NPP), describing opportunities for increasing value in health care.

The briefs outlined three key opportunities to help prevent up to \$84 billion in wasteful health care spending:

- 1) A \$21 Billion Opportunity: Preventing Medication Errors – through improved care coordination, communication and engagement of patients and their care givers
- 2) A \$38 Billion Opportunity: Reducing Emergency Department (ED) Overuse – through patient-centered health care delivered at home, which has shown a 37 percent reduction in ED use, increased offering of weekend hours from primary care providers, increased use of interactive telehealth, and availability of 24/7 telephonic consultations with physicians and nurses
- 3) A \$25 Billion Opportunity: Preventing Hospital Readmissions – through enhanced discharge planning, nurse advocacy for patients in managing follow-up care, medication reconciliation and pharmacist medication management oversight
